## Judge course in Prague, October 5-9, 2022

EXAMS AND PARTICIPATION REQUIREMENTS	
NEW JUDGES AND JUDGES RAISING UP THEIR LEVEL	These participants are required to be present at the judges' course from 5 October to 9 October 2022.
	These participants are required to pass the exams on 9 October 2022.
JUDGES KEEPING THE LEVEL – RE-CERTIFYING COURSE	These participants are required to be present at the judges' course from 7 October to 8 October 2022.
	These participants are required to pass the exams relating to the new AGG rules. They will have the possibility to pass the exams on 9 October 2022 or on another date which will be announced latter (there will be more options: at an IFAGG event or on-line).
EFFECTIVENESS OF THE EXAMS RELATING TO THE NEW RULES	The successfully passed exams relating to the new AGG rules shall come into force from 1 <sup>st</sup> of January 2023 when the new rules will become effective.

By the same decision, teams from Russia and Belarus are not allowed to participate in the European Championships and Junior European Championships 2023.
